### **Scholarship Requirements and Guidelines**

In order to qualify for the WIM MT Scholarship, the applicant must meet the following requirements:

1. Currently enrolled, or plan to enroll by Fall 2025, at a university or college in Montana.
2. Have a desire to work in the mining industry after obtaining a degree.
3. Have a GPA of 2.75 or higher.

All scholarship applications and supporting documentation must be received by the scholarship committee no later than **May 15, 2025**. The WIM MT Scholarship Committee will review all completed applications and notify the selected recipient of the award by June 15, 2025. Funds will be mailed by check to the recipient upon notification of scholarship award.

Scholarships are not automatically renewed. Recipients are invited to reapply as long as they continue to meet the application requirements.
